

## **Brighton i360 Climb 360 Waiver**

## PLEASE READ AND SIGN TO ACCEPT OUR TERMS DETAILED BELOW.

- 1. Climb 360 takes place in restricted, operational areas which house the moving parts and mechanisms for operating the Brighton i360 Pod and as such this tour is not fully accessible. If a participant has any access requirements, they should contact bookings@brightoni360.co.uk before booking.
- 2. Climb 360 requires physical exertion to complete the experience. The open-air platform is accessed from inside the tower via 105 rungs on a series of sheer vertical ladders separated by metallic platforms which can be dirty as part of Brighton i360 operations. Participants must therefore have a reasonable level of fitness and be of sound health in the event of an emergency evacuation from these areas.
- 3. There is a weight limit of 125kg.
- 4. Brighton i360 staff will accompany participants at all times during the climb.
- 5. Due to the nature of the experience, we can only accommodate a maximum of six people per climb.
- 6. All participants will be required to wear a climb suit, safety harness, and helmet provided by Brighton i360 for the climb and must keep them on throughout the experience.
- 7. All participants should wear suitable clothing for climbing that will allow them to wear a climb suit over the top and will not restrict movement or lead to overheating in warm conditions.
- 8. All participants should wear practical footwear (no high heels) that is suitable for climbing.
- 9. No loose items, including cameras and mobile phones, food, or beverages can be taken on the climb.
- 10. Brighton i360 has the right to stop the experience at any time following any unsafe or negligent behaviour from participants.
- 11. Brighton i360 has the right to refuse entry without refund to participants who have not complied with these conditions both before and during the climb.
- 12. Brighton i360 takes no responsibility for accidents that may occur during this climb as a result of negligence on behalf of the participant.
- 13. Participants must not be under the influence of alcohol or legal or illegal substances which would make it unsafe for them to participate in the climb or to understand the Safety Briefing on the day of the climb. Participants may be asked to perform a breathalyser test before the climb.
- 14. Participants must be over 12 years old; those aged between 12 and 15 must be accompanied by a paying adult aged 18 or over on a ratio of 1:2 and must be capable of undertaking the ladder climb unaided.

- 15. Climb 360 will take place in all weather conditions other than gales, lightning, heavy snow or ice, or extreme weather conditions which we reasonably believe might make it unsafe at the top of the tower. If we have to cancel a tour due to weather conditions, tickets will be extended by three months.
- 16. Due to the live operational nature of Brighton i360, it is possible that advertised dates and timings may be altered. The effect on date and timings is likely to be minimal, and participants will be contacted at the earliest opportunity via email if their climb is affected. When a service cannot be provided, ticket holders will be informed, and tickets will be extended by three months.
- 17. When participants arrive late for a climb, every effort will be made to get them to the group, however, due to the live operational nature of Brighton i360, no refunds will be given in the event of staff not being able to add them to the group.
- 18. Toilet facilities are not available during the climb but will be available to use within the Brighton i360 beach building before and after the experience.
